DEED OF PERSONAL GUARANTEE & INDEMNITY

In consideration of **Kwikserv Formwork & Scaffolding (VIC) Pty Ltd** ACN **110 883 817 (Kwikserv**") granting the Customer (as named in the Credit Account Application Form and which forms a part of this document) credit, **I/WE hereby agree:**

- 1. to personally guarantee to Kwikserv the due and punctual payment by the Customer of all monies at any time owing and payable by the Customer to Kwikserv, including any monies in excess of any credit limit granted to the Customer whether or not approved by the Customer and/or us, at the time of this Guarantee or at any subsequent time;
- 2. that this is a continuing guarantee;
- 3. to indemnify Kwikserv against all loss or damage arising from any past, present or future dealing with the Customer or any of us;
- 4. that our liability under this guarantee is joint and several and will not be affected, waived or discharged by the reason of any time or indulgences granted by Kwikserv or any grant to any of the Guarantors of a release whether in whole or in part from any obligation contained in, or implied by, this guarantee;
- 5. that our liability under this guarantee shall not be avoided, released or affected by Kwikserv making any variation or alteration in terms of any agreement with the Customer;
- 6. that this guarantee becomes binding on those of us that sign this guarantee irrespective of whether or not all intended signatories execute this guarantee;
- 7. that Kwikserv is entitled to recover against any of us (as a Guarantor) without having first taken steps to recover against the Customer or any other Guarantor;
- 8. that this guarantee may not be unilaterally revoked by us and remains in force until such time as we receive written confirmation from Kwikserv that we are released from our obligations and liabilities under this guarantee:
- 9. that if Kwikserv forms the view, for any reason, after it receives a payment from the Customer and applies the payment to a debt owed by the Customer, that Kwikserv is obliged to disgorge the payment or portion thereof to a Liquidator appointed to the Customer, Kwikserv's rights are reinstated in relation to the debt that Kwikserv applied the payment to (as if the payment had never been made) and I/we shall be liable to pay Kwikserv the amount it disgorges to the Liquidator;
- 10. to further indemnify Kwikserv against any and all losses and legal costs (on a full indemnity basis) that Kwikserv directly or indirectly incurs as a result of disgorging monies to a Liquidator of the Customer;
- 11. to hereby jointly and severally charge in Kwikserv's favour all our estate and interest in any land, whether freehold or leasehold, in which we now have any legal or beneficial interest, or in which we later acquire any such interest in, with payment of all monies owed by the Customer or any of us and consent to Kwikserv lodging a caveat or caveats which note Kwikserv's interest in or over any of our real property;
- 12. to sign in both our personal capacity and as Trustee of every Trust of which I/we are Trustee and/or a beneficiary;
- 13. to be liable for all Kwikserv's collection and legal expenses (on a full indemnity basis) with respect to taking any action to preserve and/or enforce Kwikserv's rights under this Guarantee and the Indemnity:
- 14. that the Guarantor cannot assign this guarantee without the prior written consent of Kwiksery;
- 15. Kwikserv can assign this guarantee to a third party without the consent of the Guarantor;
- this guarantee is governed by the law of the State of Victoria and the parties submit to the non-exclusive jurisdiction of the Courts of Victoria for the conduct of any litigation.

GENERAL:

- The invalidity or unenforceability of any provision of this Guarantee shall not affect the validity or enforceability of the remaining provisions.
